#### **New Laser Gives Patients a Fresh Start**

Local governments partner with VMC Foundation donors to make this exciting advancement in care possible

Years of trauma and neglect were destabilizing to Rebecca Esparza's young life. She was just 15 years old when she got her first tattoo, followed by several more. Some poor choices resulted in a brief stay at juvenile hall.

A supportive case manager was able to help Rebecca map out a more hopeful future, which included thinking about how her tattoos might affect her job prospects. Rebecca's case manager helped her enroll in the City of San Jose's Clean Slate Tattoo Removal Program.

Clean Slate was created in 1994 to allow former gang members to "wipe the slate clean" and remove the tattoos that visibly linked them with gangs and crime. The program has grown to serve victims of human trafficking who are often branded with tattoos as a sign of ownership.

Rebecca will graduate from Cal State East Bay next spring with a communications degree. She is also a part-time recreation leader with the City of San Jose, working with the Clean Slate Program to help other young people seeking new beginnings.

"I appreciate being given the opportunity to remove my tattoos for free, but most of all I appreciate the supportive staff at VMC and Clean Slate. They have made a huge difference in my life," shared Rebecca.

Because of generous funding from the County of Santa Clara, the City of San Jose, and donors to the VMC Foundation, newer, state-of-the-art

tattoo removal laser equipment is ready at SCVMC to help others make fresh starts. The upgraded equipment requires fewer treatments per patient, decreases treatment time and is less invasive.
